



## DIRECT DEPOSIT AND PAPERLESS STATEMENTS

Dear Revenue Interest Owner:

PureWest Resources, Inc. (fka Ultra Resources) offers direct deposit to all Revenue Interest Owners. This is a great opportunity to receive payments electronically. It is safe, secure and offers many advantages which include no more lost or stolen checks, no more trips to the bank and timely payments.

### Direct Deposit Requirements:

- ✓ **Attach a voided and blank check;** temporary checks and deposit slips will not be accepted.
- OR
- ✓ **Attach a Bank Letter**
    - Letter must be on the bank's letterhead which includes all bank account numbers, PureWest owner number, full name and address of owner, and signed by an authorized bank account representative with their contact information.
  - ✓ **If these items are not included, we will not be able to make the update.**

### EnergyLink Information:

PureWest is partnered with EnergyLink (Enverus) to provide Revenue Interest Owners with secure online access to their monthly and historical statements. The platform offers faster access to payment details, clear visibility into well-level data, and convenient download options for recordkeeping—all at no cost. Direct deposit enrollees will access their statements through EnergyLink (Enverus).

You can access your current and archived monthly check detail from EnergyLink (Enverus) as follows:

- ✓ Log on to the EnergyLink – [www.energylink.com/Public/Signup.aspx](http://www.energylink.com/Public/Signup.aspx)
- ✓ Select the Operator Region: United States
- ✓ Select Document Type: Revenue
- ✓ Select Operator: PureWest Resources Inc
- ✓ Enter your owner number from a previous check as well as the check date and amount.
- ✓ Complete the new user setup, creating your own login and password, as well as the security question for future correspondence.
- ✓ After successful login, access your information by selecting the Check/Invoice search tab.

You may view and print the check remittance, or you may elect to have the remittance notice emailed to you. This may be done by accessing the Account Options in EnergyLink.
